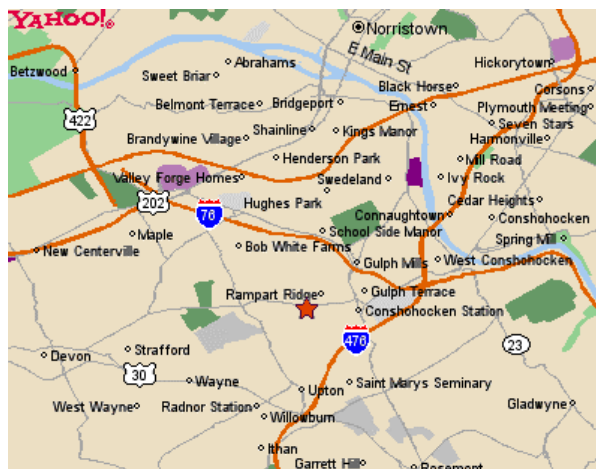




On behalf of:

Electrical Maintenance Practices and Design Considerations for Power Quality

Program Summary:

The keynote address on electrical maintenance practices and design considerations will be from Mr. Larry Ray whom will present several case studies that highlight design and maintenance practices relative to power quality improvement and disturbance mitigation. These case studies include harmonic distortion, wiring and grounding, voltage sags, and protective coordination.

In addition to Larry's keynote presentation, Bill Luddy of IETC and Dennis Link of Karden Construction Services, will present electrical maintenance cases studies and experiences from their respective industry perspectives.

Speakers:

Larry Ray, PE, is national manager of Square D Services Power Systems Engineering group. He is responsible for power quality and power system analysis, design, and monitoring services for Square D customers. Larry received the BS degree in mechanical engineering from North Carolina State University in 1979. He is a senior member of the Institute of Electrical and Electronics Engineers. Larry serves as dean (past-chair), IEEE Standards Coordinating Committee on Power Quality (SCC-22), and past-chair, IEEE Standard 1159-1995, the *Recommended Practice for Monitoring Electric Power Quality*. He is a registered professional engineer in North Carolina, South Carolina, and New Jersey.

Bill Luddy, PE, is the President of Innovative Engineering Testing and Construction in York, PA. IETC is an electrical engineering, testing and construction firm with expertise in power quality and new power technologies.

Dennis Link, PE, is President of Karden Construction Services providing a wide variety of construction project services.
