Arc Flash Studies (NFPA 70E)

Program Description:

Arc flash analyses and our commitment to the requirements of NFPA 70E have been the norm in our industry since the early 2000's. Over the last decade and a half, we've seen and reacted to changes in 70E every three years. However, the calculations from which our analyses have been based have not changed -- until now. IEEE 1584-2002 "IEEE Guide for Performing Arc-Flash Hazard Calculations" has finally been updated with the recent release of IEEE 1584-2018. This discussion will briefly review the basics of arc flash, explore the evolution of the subject over the last 15 years or so, and then dive into the significant changes of the new calculation guidelines. Practical methods to reduce high incident energy points will also be discussed.

Speaker: Al Baum, P.E., Principal, AB Engineering, LLC

Mr. Baum has over 30 years of industrial power systems and utility generation experience. His professional career started in 1988 with Westinghouse Power Generation Service.
